RE: Postponed Transition from CareConnection to Atrezzo Next Generation

(Atrezzo or ANG)

As stated in memoranda on July 14 and August 5, 2025, Acentra Health and BMS are preparing to replace CareConnection with Atrezzo/ANG for the ADW and PC programs. **The go-live dates are now the following**:

- ADW on November 3, 2025
- PC on December 1, 2025.

Because it launches first, the ADW training schedule is attached to this memorandum. Registration will open soon. Stay tuned for the PC training schedule.

CareConnection® will be **unavailable** one week prior to go-live. All providers should have their work completed by close of business on 10.24.25 for ADW. Acentra Health will share training, technical assistance, and periodic updates with providers to assist with the transition. Module 1 – Provider Portal Administrator Training 30-minute session; 3 sessions; all times below are ET

The objective of this 30-minute training session is to demonstrate how to access the Atrezzo Provider Portal and all Administrator role functions. During this session, users will learn how to login, complete multi-factor authentication (MFA) registration, and all administrative functions including adding and managing users, adding additional NPIs, and resetting MFA for active users. This session is for all Administrator users. An administrator is commonly a supervisor or manager as they will have the highest system permissions. Initially only one administrator should be designated to register for the provider portal. Additional administrators can be added once initial registration is complete.

Module 2 – Provider Portal System Training 60-minute session; 6 sessions; all times below are ET

The objective of this 60-minute training session is to demonstrate how to submit cases, upload supporting documentation, utilize the message center, and all provider portal functions. This session will be for all users who will have access to the provider portal to submit cases.

All provider groups will need to dedicate a Provider Group Administrator that needs to attend Module 1 – Provider Portal Administrator Training to learn how to manage provider portal accounts.
